2. 3. Sanction of the competent authority is also accorded to the carry forward of unspent balance of Rs. 15306/- (Rupees Fifteen Thousand Three Hundred and Six only) (Recurring Rs. 15306 and Non-Recurring Rs. 0) to Doon University, Campus Office, 388/2, Indira Nagar Dehradun from FY 2017-2018 to FY 2018-2019 for the same purpose for which it was sanctioned.
4. Sanction of the grant is subject to the conditions as detailed in Terms & Conditions available at the website (www.serb.gov.in).
5. It is certified that provision of GFR 212 relating to Utilization Certificates (UCs) for the funds released under the grant have been satisfied and the UC/s is/are enclosed herewith.
6. The expenditure involved is debit to Fund for Science & Engineering Research (FSER) This release is being made under Early Career Research Award. (EC Chemical Sciences) (GEN)
7. The Sanction has been issued to Doon University, Campus Office, 388/2, Indira Nagar Dehradun with the approval of the competent authority under delegated powers on 22 May, 2018 and vide Diary No. SERB/F/1335/2018-2019 dated 28 May, 2018




