# Admission Announcement for Ph.D. programs for the session 2024-25

#### Information/Guidelines for admissions to Ph.D. programs for academic session 2024-2025:

- 1. The University Grants Commission (UGC), vide its notification dated 27.03.2024 decided that from the Academic Session 2024-25, the National Eligibility Test (NET) score can be used for admission to Ph.D. programs in place of entrance tests conducted by the different Universities/HEIs.
  - Therefore, from the academic session 2024-25, the Doon University will use the National Eligibility Test (NET) scores for admission to Ph.D. Programs.
- 2. The following will be the key eligibility requirements for Ph.D. Admissions at the University:
  - i) Candidates with National Level Examinations: Candidates who have qualified national level exams like JRF (UGC/CSIR), NET (UGC/CSIR) and GATE.
  - ii) Candidates with NET Qualification (Ph.D. only): Candidates who have cleared the National Eligibility Test (NET) for Ph.D. (Category-3).
  - iii) DST-INSPIRE Fellowship Holders: Candidates who have secured a DST-INSPIRE Fellowship.
- **3.** Based on the scores obtained in NET, the candidates will be eligible in three categories.

#### In accordance with the above table, Ph.D. Admissions will be given as below:

- i) JRF- Qualified students may be given admission into the Ph.D. Programme based on Interview as per the UGC Ph.D. Regulations, 2022. The Candidates with valid UGC NET with JRF shall be called for interview and, the interview shall carry 100% weightage.
- ii) Students who qualify in Categories 2 and 3, 70% weightage will be given for test scores and 30% weightage for the interview for admission to Ph.D. program. The Ph.D. admission will be based on the combined merit of NET marks and the marks obtained in the Interview.
- iii) The marks obtained in the NET by the candidates in Category 2 and 3 will be valid for a period of one year for admission to Ph.D. Programs.

- **4**. For GATE Qualified candidates, 70% weightage will be given for valid GATE test marks and 30% weightage for the interview for admission to Ph.D. program. The Ph.D. admission will be based on the combined merit of GATE marks and the marks obtained in the Interview.
- 5. Candidates who have secured a Provisional Offer for DST-INSPIRE Fellowship may be given admission based on Interview and, the interview shall carry 100% weightage. However, admission of such a candidate shall be provisional till he/she gets Final Offer for DST-INSPIRE Fellowship (after clearing Level-2). If the candidate fails to get a Final Offer, his/her admission shall be cancelled. The Department concerned of the university shall make it very clear to such candidates and shall seek an undertaking to the effect before granting provisional admission to such candidates into their Ph.D. Programmes.
- **6.** After concluding the process of filling of online application form candidates will be called for interview and merit list will be prepared. For which information will be notified through the university website.
- 7. Candidates are required to fill the online application form by visiting the University website.

- **❖** University reserves the right to withdraw any programme if the situation so warrants. seats can be increased or reduced.
- ❖ The admission in the academic program is subject to fulfillment of the eligibility criteria. The University reserves the right to cancel the admission at any point of time, if the provided information by the candidate is found to be incorrect/ misleading.
