Action Take Report

- After receiving the complaint, the complainant was approached immediately. His detailed report was received. He was assured of full security by deploying a security guard besides his room in the hostel.
- The accused were called for their statements for verification and further investigation.
- The hostel staff and some witnessed were approached for further investigation.
- The wardens were approached as part of the investigation and to provide their comment on the incidence.
- A thorough investigation was performed by involving witness students and hostel staff.

On the basis of investigation report of Anti-ragging squad and boys hostel wardens, it was concluded that there are evidences of the rift between the complainant and the accused since last semester and is not exactly the act of ragging. However, the accused student Abhishek Rawat physically abused the complainant on record and hence, is subject to the punishment. The squad recommends **expulsion from Hostel of Mr. Abhishek Rawat** for one semester though, the competent authority may change the quantum of punishment if finds appropriate.

The investigation report along with the statements/documents has been submitted to the Anti-ragging committee for further action.





Minutes of Meeting

 - (c) The Anti-Ragging Squad hence recommends the appropriate disciplinary actions against both the parties.

Report on anti-ragging awareness activities in Doon University.


Madam,

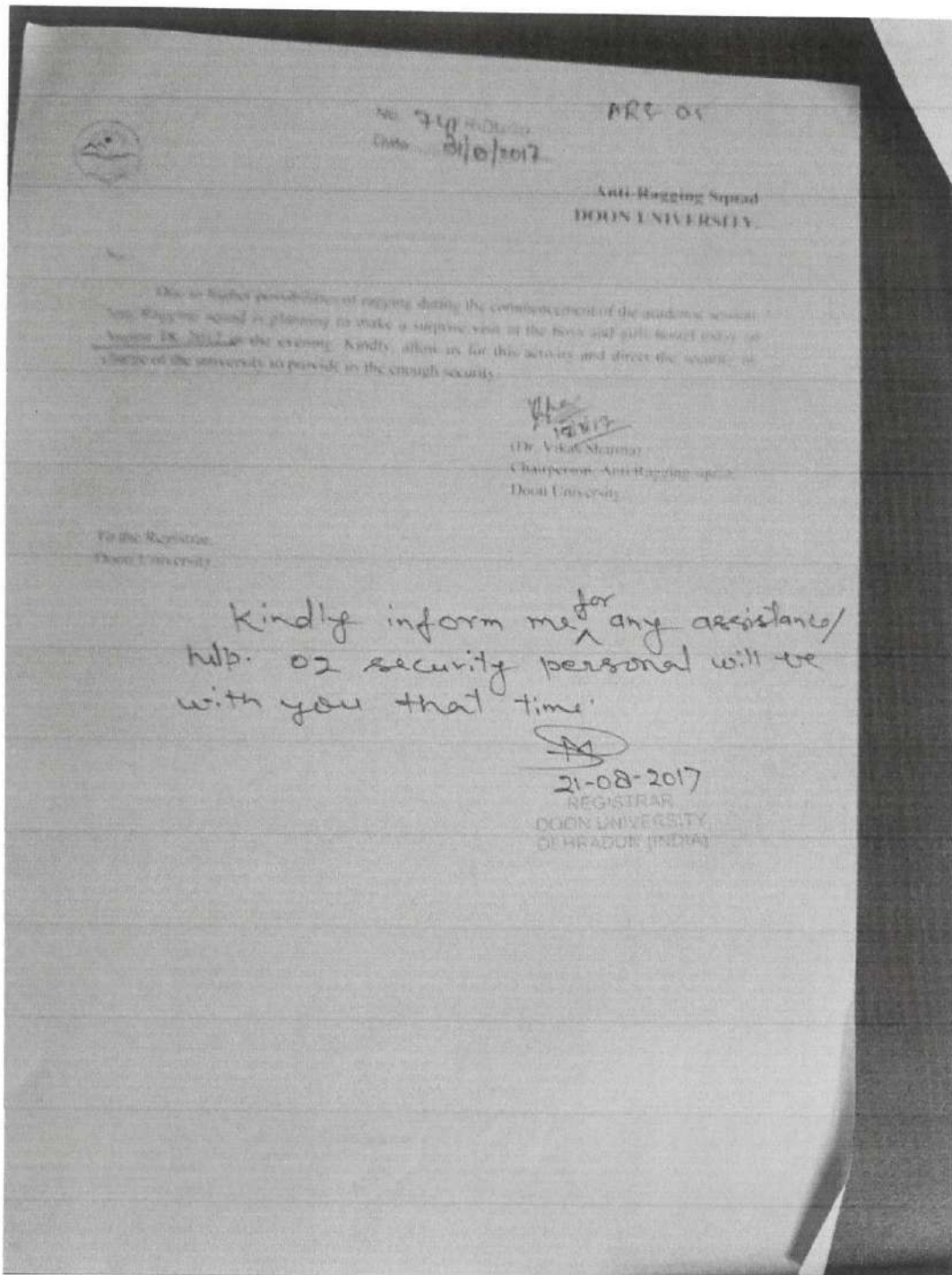




